In addition, Alan represents clients before the Colorado Ground Water Commission, in rulemaking before the Colorado State Engineer and in administrative proceedings before the Environmental Protection Agency, the Colorado Department of Public Health and Environment, Colorado Division of Reclamation, Mining and Safety, local planning commissions, and other state and federal agencies. He also advises clients in transactions involving the purchase and sale of water rights, including ownership issues, preparation of documents for closing and resolution of disputes.

He has lectured and authored articles on various issues regarding Colorado water rights, water rights transactions and issues related to oil and gas production and fracking and its impacts on water quality and quantity.
